Permanent visas for all refugees living in Australia

Many Australians are deeply concerned about the wellbeing of refugees living in Australia on Temporary Protection Visas (TPV -3 years) or Safe Haven Enterprise Visas (SHEV -5 years).

These visas are not permanent protection visas. They place refugees in a continual state of extreme stress, fearing that they may eventually be returned to the country from which they fled persecution.

This group -called the ‘Legacy Caseload’- is grossly discriminated against by the Federal Government because they arrived by boat. This ignores the rights of refugees under international law.
